



“New Member” Official Rules

Times/Dates:

Eligibility:

1. Eligibility will be limited to all Saracen Player’s Club members with a valid, government issued photo ID
2. Banned individuals are not allowed to participate in any promotion at Saracen Casino Resort
3. The following persons shall not be eligible to participate in this promotion:
 - a) Any person under the age of 21
 - b) Any current employee of Saracen Casino Resort, including employees of any Quapaw Nation gaming facility
 - c) Elected and appointed officials of the Quapaw Nation

Kiosk Game requirements:

1. All Saracen Player’s Club members with a valid Saracen Player’s Club card may swipe their card to play the *New Member Sign Up* game.
2. Saracen Player’s Club members must swipe their Saracen Player’s Club card after becoming new card members.
3. Once they touch the Promotion on the Kiosk they will play the New Member Sign Up game for a chance to win between \$5 and \$500 in Free Slot Play.
 - a. Amount won is based on par levels set within the game.
 - i. Free Slot Play will be added directly to the customers Saracen Player’s Club card via the Everi Promo Kiosk.
 - ii. Free Slot Play will be \$5, \$10, \$15, \$20, \$25, \$50, \$100, \$150, \$200, \$500.
 - iii. All Free Slot Play will be valid for 48 hours from issue date.
 - iv. Prizes must be redeemed within 48 hours of issue date.
