



“Money Tree Thursday’s” April 2021 “ Official Rules

Times/Dates:

1. **Entry Earning Times & Dates:** Thursday, April 1, 8, 15, 22, 29, 2021 8am – 8pm
2. **Entry Activation Times & Dates:** N/A
3. **Drawing Times & Dates:** N/A

Eligibility:

1. Eligibility will be limited to all active Q-Club members with a valid, government issued photo ID
2. Banned individuals are not allowed to participate in any promotion at Saracen Casino Resort
3. The following persons shall not be eligible to participate in this promotion:
 - a) Any person under the age of 21
 - b) Any current employee of Saracen Casino Resort, including employees of any Quapaw Nation gaming facility
 - c) Elected and appointed officials of the Quapaw Nation

Kiosk Game requirements:

1. All Q Club members with an active Q-Club card who earn 25 points on Slots or tables on the promotional day may swipe their Q- Club card at the promotional kiosk to play the Money Tree Game
2. Once they touch the Promotion on the Kiosk they will pick a coin off the Money Tree for a chance to win between \$5 and \$100 in Q-Play
3. Q-Club Members may only play 1 time each promotional day.
